Psi Diamond Update

Psi Brothers,

Three months ago I agreed to become the interim president (pending election at Homecoming this fall) of the Psi Diamond Association. Like some of you, I had not been very active in our illustrious fraternity for many years. I was amazed to learn of the recent history of the greatest fraternity at Bethany College. For four years, from 1973 to 1977, Psi Chapter of Beta Theta Pi was my home and my family.

Bethany College changed over the years and to my surprise so did Beta Theta Pi. Fortunately, we have had a dedicated group of Brothers that would not compromise the principles of the fraternity, or what it meant to Psi Chapter alumni.

Beta Theta Pi is an international fraternity, founded in 1839. Psi Chapter has been a vibrant part of the Bethany College campus life since 1860 and has been an important contributor to Bethany financially, academically and socially. Many Betas have gone on to prominence in numerous professions including; law, medicine, business, politics and finance. Betas continue to play a significant role in their communities as civic leaders, coaches and active volunteers for non-profit organizations.

What makes Betas different? What transforms immature seventeen year-olds into men ready to take on day to day challenges and lead their co-workers in demanding, career building assignments? What makes men of integrity, willing to take on injustice or even corruption for the sake of what is right and just?

As graduates of Bethany College and members of Beta Theta Pi, we know the answer. It is a combination of a fine education, an opportunity to interact with professors and administrators who care and the chance to be tested in an environment that was both challenging and supportive. But as important as any education, it was living in an environment with the spirit of Beta Theta Pi!

The Beta Theta Pi experience began for most of us the minute we stepped on Bethany's campus. It was the way the Beta Brothers carried themselves in the classrooms, on the athletic fields, took positions of leadership in campus life, and were revered by others on campus. In the social arena, it included the parties at the Beta House, the attention we received and good times had during campus activities, concerts, symposiums and even in the cafeteria. There always was something special about the Betas; what they stood for, their position of prominence, and most importantly how they cared about and for each other. Behind closed doors we could have some raucous disagreements, but what ever you do, don't "cross my brother!"

Bid Day at Bethany was a wild time, a time of absolute exhilaration. Pledging Beta was an easy decision and being accepted into the Brotherhood was a true honor. As we all know, Bid Day was only the beginning. What developed over the next four months

helped to transform us into a united group of young men that had tremendous respect for each other and a bond that would last a lifetime!

Unfortunately, dark days came to Bethany and to Psi Chapter in 2002 when a steady decline in the quantity and quality of students resulted in a situation that could no longer be tolerated. Leaders of Psi Diamond Association made the decision that the only way to preserve the Psi Chapter was to close our doors for a few years and then apply to the General Fraternity to re-colonize the chapter at a later date. This decision was very difficult, but Betas are used to weighing all the options, making tough decisions and then insuring that things are done the right way. This decision was no different.

After three years, a new day is dawning for Beta Theta Pi at Bethany College. We are formally embarking on the re-colonization of Psi Chapter. Re-colonization is a formal process set out by our General Fraternity in Oxford, Ohio. The detailed documents were signed by the leadership of Psi Chapter, Bethany College and the General Fraternity. We are aggressively moving forward with "The Men of Principle" program that has been embraced by many chapters of Beta Theta Pi.

It is not an easy process, but nothing worthwhile is ever easy. But more than anything, it is the right thing to do. It is the right thing to do because young men entering Bethany College in the years ahead should have the same opportunities as each of us had as freshman. They should be afforded the opportunity to proudly wear the Beta Dragon, drink from the The Loving Cup and understand the history of those who have come before them: "The Son's of the Stars."

What is our role as members of Psi Chapter of Beta Theta Pi and alumni of Bethany College? We must find a way to give back some of our time and money to support what has meant so much to each one of us. We must help to re-colonize Psi Chapter. We must make this happen for future generations of young men and keep the traditions and friendships of old.

As a member of Beta Theta Pi, I remember the contributions made by alumni and how much it meant to me and all the Brothers. Now it is our turn. Please take your place alongside your Brothers and be a part of this re-colonization effort. Many hands make for light work! Please be a part of this critical project.

Re-colonization Summary

What you can expect from the General Fraternity:

An efficient and thorough campus preparation process will occur six months prior to the re-colonization efforts taking place and will ensure logistical components of a successful return are secured

A committed and professional three-man expansion team that will execute a successful re-colonization project in a 22-day period during the 2005-2006 academic year.

Long term support from Education Consultants and a colony educator that will stay on site to facilitate the 7-week colony education program.

Re-colonization classes average range from 24 to 55 men in size with the average class being 30 men.

Beta Theta Pi offers a minimum of two Advisor Training Conferences (ATC's) each year, one in Oxford and one during our General Convention, as well as requested regional training sessions in areas that justify the need for an ATC.

Requirements that have been accomplished to-date:

- ✓ Complete the Alumni Partnership Agreement. **DONE**
- ✓ Decide when the ideal re-colonization launch will happen. **DONE**
- ✓ Establish a Psi Chapter Leadership Fund of \$10,000 and commit to annually fund a full delegation of participants to experiential leadership opportunities (i.e. the Institute for Men of Principle, Beta Wilderness Challenge, UIFI) **DONE**
- ✓ Ensure Housing and Internet capabilities are in place to support the three-man expansion team for 22 days of recruitment as well as the colony educator during the seven-week colony education period. **DONE**
- ✓ Psi alumni to fund \$1,000 towards "Recruitment Through Scholarship" awards to be utilized in the re-colonization process. **DONE**
- ✓ Recruit and train a minimum of 5 advisors that are not members of the housing corporation. These advisor roles include:
Chapter Counselor; Financial Advisor; Pledge Education Advisor; Recruitment Advisor; and Risk Management Advisor. *See the advisor team photo below.*
DONE

Foster an alumni brotherhood that supports the Mission, Vision and Goals of the Men of Principle Initiative; one committed to ensuring that Psi Chapter undergraduates experience and adhere to living the Principles and Obligations of Beta Theta Pi Fraternity.

Mid-Year Report

It gives me great pleasure to inform the Psi Chapter alumni that the Psi Chapter Diamond Association Charitable Foundation, Inc. (“Charitable Foundation”) is as solid as ever.

The Charitable Foundation is a non-profit corporation, organized under the laws of the State of West Virginia. The Internal Revenue Service has ruled that the corporation qualifies under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and is, therefore, not subject to tax under the present income tax law. The corporation is currently in good standing with the State of West Virginia.

The Charitable Foundation’s investments are held by JPMorgan Chase Bank, N. A. (JPMorgan Chase). The Board of Directors has retained JPMorgan Chase to serve as the Investment Advisor. The following presents the fair value of investments. As of July 31, 2005 the Charitable Foundation’s account is funded with a current balance (market value of investments) that totals \$507,794. Year-to-date income totals \$2,353 with \$1,103 of that amount derived from long term capital gain dividends and \$1,250 in other earnings.

The Charitable Foundation remains poised to adhere to its guiding principles to provide support to Psi Chapter, Bethany College and Beta Theta Pi. Two distributions were made during 2004, for a total of \$23,000, \$20,000 of which went to the House Corporation. Prior to those expenditures, the CF made disbursements to the House Corporation to pay off its mortgage and fund needed repairs, to support the general fund of Bethany College and to help support Beta Theta Pi’s “Men of Principle” program. The Charitable Foundation appreciates the hard work and dedication being put forth to affect the Psi Chapter Re-colonization effort that is earnestly underway and stands ready to provide support to these efforts in conformance with the guiding principles upon which the Charitable Foundation was created.

As we go forward with the Re-colonization effort to bring Psi Chapter back to life on Bethany College’s campus, I look forward to your continued support. Support of the Charitable Foundation.....Support of the Diamond Association.....and last, but not least,.....Support of Psi Chapter!

Frequently Asked Questions

Question	Answer
What are the various alumni groups associated with Psi Chapter?	There are three alumni bodies which serve to promote the wellbeing of the chapter. <ol style="list-style-type: none"> 1. Psi Chapter Diamond Association (PDA) 2. Psi Chapter House Corporation (HC) 3. Psi Chapter Diamond Association Charitable Foundation Inc. (CF)
What is the Psi Chapter Diamond Association?	The Psi Diamond Association (PDA) makes up the main body of alumni with a mission to encourage the continued assistance of Psi alumni to foster the social, spiritual, and economic rebuilding of the Psi Chapter of Beta Theta Pi. The Diamond Association was established at the chapter's 75 th Anniversary Celebration in 1936. The PDA, by definition, is a support organization of the alumni for the chapter. That mission includes the encouragement of participation in Psi activities which does include fund raising. The PDA consists of Betas who continue to believe in and want to continue to support the values and purposes of Beta Theta Pi and Psi Chapter.
What is the purpose of the PDA?	The purposes of the PDA include: <ul style="list-style-type: none"> - Assist the House Corporation with general maintenance and supply needs over and above the normal expenses supported by the rent. - Provide support for the active chapter in any capacity required such as fund raising; alumni communications; recruiting (formerly called rush); pledging scholarship assistance; attendance at General fraternity events, conventions; etc.
Are donations to the PDA tax deductible?	While donations to the PDA are not tax deductible, their use is unrestricted. Donations to PDA can be "ear marked" according to the donors wishes or if not indicated otherwise, used in a manner of greatest need.
Are there PDA membership requirements? What are these requirements?	Yes. Membership to PDA requires that you first be a member in good standing of Beta Theta Pi General Fraternity. As such all Psi Chapter alumni are asked to give annually to the PDA. R.D. Hurl wrote in his 1935 letter announcing the formation of the PDA: "No definite membership fee has been set. This has purposely been left open so each fellow can make the fee to suit his pocketbook." Brother Forrest H. Kirkpatrick '27 #365 wrote the following of PDA membership. "The Psi Diamond Association is an organization made up of our "Silver-Grays" and members of our chapter. Its purpose is to provide a continuous interest in, and support for the active chapter, by these who have been privileged to membership. The membership is purely voluntary and dues are not in the form of assessment ..." Current day donations are typically in the \$25 to \$500 range of contribution or service. Note that a donation directly to the CF or the HC would be considered as credit towards PDA dues for that calendar year.
Do I have to be a member of the PDA in order to participate in any of the other two alumni groups?	Yes. In order to participate in the CF, for instance, our Bylaws state that in any given year, each member must have made a contribution to the Psi Chapter Diamond Association in the preceding calendar year. Participation and voting then in the other alumni groups (CF or HC) first requires membership to the PDA or contributions to either organization starting the year prior this involvement.
What is the Psi Chapter House Corporation?	The Psi Chapter House Corporation (HC) is organized (Incorporated in 1922) for the purpose of owning and financing the real property of Psi Chapter. This corporation serves as the landlord for the Psi chapter house and oversees the management, repairs and maintenance of the chapter house. Funds for the HC are generated primarily from the rents collected, although it has been supplemented by the generous donations of many alumni.
What is the Psi Chapter Diamond Association Charitable Foundation Inc.?	The Charitable Foundation (CF) was incorporated August 8, 1978 for the purpose of supporting Bethany College and other such worthy charitable purposes and objectives. This entity also provides a vehicle for tax deductible contributions since the CF is a 501(c)(3) tax exempt charitable organization. It provides for a perpetual charitable foundation in which the corpus is invested and reinvested by our investment committee and the interest income is distributed for scholarships, Bethany College donations, support for our real property investments, and other approved purposes of the CF. What level of giving is typical to the CF?	While there is no set dollar minimum for donations to the CF, your choice of giving to the CF should be based on the purpose of the CF, while taking advantage of the favorable tax treatment. Please consult your tax or financial advisor for advice on how you may benefit from the tax exempt status of the CF. Note that donations to the CF may be restricted - unlike those funds given to the PDA, and may only be distributed according to the Bylaws of the CF.
What is the Men of Principle initiative?	Men of Principle is a partnership between undergraduates, alumni, and the General Fraternity to ensure long-term chapter success, which is grounded in Self-Governance and the Principles of Beta Theta Pi. To learn more about the Initiative, contact the Administrative Office at 800-800-2382 or visit the Beta website at: http://www.betathetapi.org/
Why is \$10,000 needed and what will it be used for?	The General Fraternity requires a balance of \$10,000.00 to be placed in an account at the General Fraternity specifically designated for Psi Chapter along with a commitment to annually fund this account as needed for the purpose of chapter leadership development. Specifically, a full delegation of Psi Chapter participants to experience leadership programs (i.e. the Institute for Men of Principle, Beta Wilderness Challenge, UFI, etc) will be an integral part of the active chapter management. Donations to this fund are sent directly to the Administrative Office in Oxford, Payable to Beta Leadership Fund, with restriction to Psi Chapter. All balances and interest accumulated are used only for Psi Chapter. These donations are tax deductible.

We will begin rushing freshman and upperclassmen in the fall and accepting a pledge class in the spring. We must compete with the other houses. Let's ensure we look our best!
